



Pool Room Guidelines

1. In the case of an emergency, please dial 911 for assistance.
2. Participants must be 18 years of age for the pool membership.
3. Members are not permitted to have guests unless previous arrangements are made with Therapy Staff. Guests must be at least 18 years old.
4. Prior to facility use, all participants and/or the responsible party are required to sign a release of liability form and receive a facility orientation/fire safety instruction.
5. You must have a valid Therapy Center I.D. Badge to gain admittance to the Therapy Center that is activated upon payment (cash or check).
6. The pool is not supervised. Please exercise at your own risk. No lifeguard on duty.
7. Participants should use extreme caution when entering and exiting pool and locker rooms to avoid potential injury regarding wet floors.
8. All accidents and injuries should be documented using the Commercial Liability Report and the Commercial Liability Report Witness Statement and turned into the Therapy Center Staff. These forms are located across the hall from the grey payment lock box in the black file holder on the wall.
9. Please use the lockers in the locker rooms at your convenience when using the facility. Items are not to be kept in the lockers when you are not using the facility.
10. Appropriate exercise attire is required in the pool. Swimsuits, aqua shoes if desired, etc.
11. Participants are encouraged to bring their own towels to use. Towels are not provided by the facility.
12. All equipment must be used in the manner for which it was designed. Do not attempt to modify the equipment. Do not attempt to use equipment if unfamiliar with the proper use. Please ask for assistance from Therapy Staff.
13. All equipment must be returned to its proper area.
14. No food, gum, glass bottles, or cans are allowed in locker rooms and pool area (unless medically needed). If you wish to carry a beverage with you, it must be water in a plastic container with a lid or cap.
15. No tobacco product of any kind is allowed to be used on the property. The Filling Home is a tobacco free facility.
16. A severe thunderstorm warning, tornado watch, or tornado warning for Henry County will automatically close the pool. No one should enter the pool when lightning or thunder can be seen or heard. The pool will remain closed for at least 20 minutes after the last thunder is heard or lightning seen. Note: The evacuation area for tornado emergencies is the locker rooms.
17. If the fire alarms sound the pool is to be immediately evacuated. No one is to re-enter the pool until the Emergency Director issues an all clear.
18. In the case Henry County has issued Level II or III winter weather advisory all activities in the pool and gym will be cancelled. These areas will be closed to all community members.

These guidelines exist for the safety and respect of all participants. Therapy Staff reserves the right to ask anyone to leave for failure to comply with these guidelines. Any behavior deemed inappropriate may result in loss of one's access privileges.
